6. Sealed Bids must be submitted to the office of **PHQ, Naxal, Kathmandu** on or before **4th December 2017 at 12:00 noon**. Documents received after this deadline shall not be accepted.
7. The Sealed Bids shall be opened in the presence of Bidders' representatives who choose to attend **4th December, 2017 at 2:00 PM** at the office of **PHQ, Naxal, Kathmandu Nepal**. Bids must be valid for a period of **90 days** counting from the day of bid opening and must be accompanied by bid security, which shall be **valid for minimum 30 days** beyond the bid validity period.
8. The bidder is required to submit full-sheet sample copy of each item of printing papers on or before the bid opening day & time, and not submitting of such sample, the bids may be declared ineligible.
