Invitation for Bids for the Construction Work under the below mentioned Contracts.

1. Tadi Rural Municipality has allocated funds towards the Construction Work under the below mentioned Contracts. Bidding is open to all eligible Nepalese Bidders.
2. Bidders may bid for one or several contracts, as further defined in the Bidding Document. Bidders wishing to offer discounts/cross discounts in case they are awarded more than one contract will be allowed to do so provided those discounts are included in the Letter of Bid.
3. **Tadi Rural Municipality** invites sealed bids **or electronic bids** from Nepalese eligible bidders for the construction of **Common Ward Office for Ward No. 5 &6 (TRM/NCB/-01/2075/76), Side drain construction and road upgrading work on Bahunbesi-Bigyan Ma. Vi.-Bhanjyang Road (TRM/NCB/-02/2075/76), Upgrading Work on Rato Paharo – Bohare-Sathiya Road (TRM/NCB/-03/2075/76), and Upgrading work on Kharanitar Tutung hudai Urleni Road(TRM/NCB/-04/2075/76)**, under National Competitive Bidding procedures.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office **Of Tadi Rural Municipality Office, Kharanitar, Nuwakot (www.tadimun.gov.np) or may visit PPMO website www.bolpatra.gov.np/egp.**

A complete set of Bidding Documents may be purchased from the office **Tadi Rural Municipality Office, Kharanitar, Nuwakot** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, Tax Clearance of fiscal year 2074/75 and upon payment of a non-refundable fee of **3000.00 NRS** till **10-01-2019 16:00** during office hours.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost(as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 6. Pre-bid meeting shall be held at **Tadi Rural Municipality Office, Kharanitar, Nuwakot** at **11-01-2019 12:00 noon**.
7. Sealed or electronic bids must be submitted to the office **Tadi Rural Municipality Office, Kharanitar, Nuwakot** by hand or through PPMO website www.bolpatra.gov.np/egpon or before **12:00** noon on **21-01-2019**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00** on **21-01-2019** at the office of **Tadi Rural Municipality Office, Kharanitar, Nuwakot**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **following amount**, which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. All other terms and conditions will be as per Nepal Government's Prevailing Procurement Act and Regulations.
11. **Tadi Rural Municipality, Kharanitar, Nuwakot** reserves the right to accept or reject, wholly or partly any or all the Bids without assigning any reason, whatsoever.
