The Government of Nepal, Ministry of Irrigation, Department of Water Induced Disaster Prevention (DWIDP) has received a fund from the President Chure Tarai Madhesh Conservation Development Committee for the construction of Revetment, Catch-drain, drain out structure and protection works along Banganga River in Kapilbastu District. Now the **Water Induced Disaster Prevention Division no. 14 (WIDPD-14)**, Rupandehi hereby second time **invites** sealed Bids from eligible bidders under the following terms and conditions:

- 1. The bidders who are registered in Government of Nepal (GON) with Permanent Account Number (PAN) may purchase bidding documents on the submission of a written application along with copies of Firm Registration Certificate, Tax and VAT clearance certificate (FY 2071/72) and upon the payment of non-refundable amount during office hours from Water Induced Disaster Prevention Division Office No. 14, Rupandehi on or before 31st (20th March 2016) day from the first day of publication of this notice. All duly filled sealed tenders must be accompanied with a Bid security amount as mentioned hereunder in the form of cash voucher deposited in A/C No.0414601014253047 in of District Treasury Office, Rupandehi in Office Code No:- 37-357-02 in Agriculture Development Bank, Bhairahawa or Bid Bond in the <u>format as enclosed by the Employer with the Bid document</u> of the same amount in the form of Bank guarantee of an acceptable commercial bank in Nepal which is valid for a period of at least 120 days from the dead line of submission of the bid.
- 3. The bid shall be enclosed in a sealed envelope clearly mentioning the name of the work, Contract No. as well as name and address along with the e-mail address and post box number of the bidders and should be submitted to: Water Induced Disaster Prevention Division Office No. 14, Bhairahawa, Rupandehi on or before 12:00 hour on the 32nd (21st March 2016) day from first date of publication of this Invitation for bids. Any BID received after the above specified date and time will not be entertained.
 - Interested eligible bidders may visit-e-GP Portal of PPMO website http://www.bolpatra.gov.np and submit their bids, modifications or withdrawal electronically.
- 4. Bids will be opened at 14:00 hour on the 32nd (21st March 2016) day from the first date of publication of the notice in presence of the bidders or their authorized representatives who choose to attend or even in their absence at Water Induced Disaster Prevention Division Office No. 14, Rupandehi. If the last date of purchasing of bid Documents, submission and opening falls on a public holiday then the next working day shall be considered as last day.
- 5. Bid will be awarded to successful bidder on post qualification basis satisfying the minimum qualification criteria as described in the Bidding Document. Failure to meet the evaluation criteria will lead to **Non Responsive Bid**.
- 6. Processing of the Bidding Documents will be carried out as per Public Procurement Act 2063 and Public Procurement Regulation 2064 and revisions up to the 1st day of publication of notice. Particulars not mentioned in this notice will be in accordance with the prevailing procurement rules and regulations of Government of Nepal.
- Water Induced Disaster Prevention Division Office No. 14, Rupandehi reserves the right to accept or reject any or all BID fully or
 partially and to annul the bidding process at any time without giving any reason whatsoever. CONDITIONAL BID will not be
 entertained.
- 8. The Bidder shall quote item rates without VAT in Nepalese Currency both in words and figures. If there any discrepancy exists between the rates in words and figures, the rates in words will prevail.
- 9. All bidders must submit a written declaration according to clause 40(2)-Ang of Public Procurement Regulation, 2064. The bidders failing to do so shall not be included in the evaluation process. This office or any of its concerned agencies will not be responsible for any expenses incurred by the bidders in connection with the preparation and delivery of bids.
- 10. All the relevant documents (original/attested) pertaining to evaluation of technical aspects should be submitted along with the bid. Hard copy of uploaded bidding documents must be submitted within 7 days in case of **e-bidding**.
- 11. Bidders are advised to visit the site and access the actual site condition before submitting their bid with their own cost.
- 12. For working in a Joint Venture, an agreement for the same should be submitted. In the case of JV bids it is compulsory for the lead partner to secure a minimum of 50% and that of all other partners to secure 25 % percent of the stipulated provision as specified in the biding data.
