NOTICE FOR ENLISTMENT

1. Directorate General of Army Aviation (DGAA), in accordance with “Security, Strategy or Defence Supply Procedure 2064 Sec 5 Sub sec 1”, hereby invites applications from reputed foreign-based manufacturers and authorized companies to enlist in the **Annual Procurement List 2018/2019** for the supply, repair and overhaul of aircraft, components and accessories of Mid Air Base and VVIP Flight Service.
 - a. **APPLICATION PROCEDURE**

A sealed and separate application in a file for each group or subgroup stated in paragraph (2) should reach this office (local time) of **2nd Aug 2018**. The applicable documents need to be filed along with the application in the specified order as stated in paragraph (1) b.
 - b. **THE SPECIFIC DOCUMENTS SHOULD BE SUBMITTED IN FOLLOWING ORDER:**
 - i) Original company application to DGAA (one separate application for each group or subgroup signed and stamped)
 - ii) **Company profile:**
 - Type of Organization [Manufacturer/ Authorized distributor or supplier/ Approved Maintenance Organisation (AMO)]
 - A Brief Summary (Production Capacity, Distribution range and financial position).
 - iii) Approval from National/ Interstate Aviation Committee or Joint - Civil Aviation Authority (e.g. CAAN- NEPAL/ EASA 145 - EU/ FAA-USA/ DGCA-INDIA / ISAC (Russia) or Civil Aviation Authority of respective country)
 - iv) Approval from both manufacturer and Civil Aviation Authority as stated in (iii) to be submitted by the AMOs and authorized distributors.
 - v) Capacity list confirmation to approval certificates as stated in (iii) and (iv).
 - vi) Quality Certificate from ISO (International Organization for Standardization)/AS (Aerospace Standard)
 - vii) An original Letter of authority for local agent addressed to DGAA stating the commission percentage amount. Appointment of a local agent is a must.
 - viii) Local agent’s Firm/ Company registration certificate in the Government of Nepal.
 - ix) Nepalese Citizenship Certificate of local agent. Local agent must be Nepalese citizen.
 - x) Business License acquired by the local agent from concerned authority of the Government of Nepal and should have classification of business for this process/ memorandum of Association.
 - xi) Registration certificate of TAX, PAN and VAT from concerned authority of Nepal.
 - xii) Self declaration letter from the local agent.
 - xiii) Tax clearance certificate as of the fiscal year B.S. **2072/73** or tax submitted details of fiscal year B.S.**2073/74**.
 - xiv) **Additional documents for VVIP FLIGHT SERVICE:** -Companies other than manufacturer must submit the acquired approval from CAAN (Civil Aviation Authority of Nepal)
2. **Supply, Maintenance, Repair, Overhaul and Services of the following aircraft's respective engines, components , accessories and Spare Parts**
 - (a) **Group 'A' Rotary Wing (Helicopters of Mid Air Base):-**
 - (i) Mi -17 IV and Mi-17 V5 (ii) Ecureuil AS 350B2, AS350 B3 and AS 350B3e (H125)
 - (iii) Lancer (NA-046/047) (iv) ALH (NA-054)
 - (b) **Group 'B' Fixed Wing (Aeroplanes of Mid Air Base):** (i) M-28 Sky truck (ii) BN2T Islander (iii) Piper (iv) CASA 235
 - (c) **Group 'C':- Rotary Wing (Helicopters of VVIP Flight Service):-**
 - (i) Bell 206 L3 and L4 (ii) Bell 407 GXP (iii) Augusta Westland (AW 139)

- (d) **Group "D"**
- (i) Electrical and Avionics (Including battery and accessories)
 - (ii) Instrument, GPS
 - (iii) Radio Communication and Navigation Instruments, Weather Radar and accessories
 - (iv) NVG, Helmet, Surveillance Camera and its equipments.
 - (v) Avionics test equipments.
- (e) **Group "E"**:- Supply and Maintenance of Ground/Cargo Handling equipments and tools.
3. **Approval Certificates of Manufacturer Company should be as follows:**
- (a) Variant of Aircraft Type, parts / components and accessories.
 - (b) Variant of Engine, Gear box, Propellers, Main Rotor Blades, Tail Rotor Blades parts/components and accessories.
4. **Category of services:** Enlistment Company shall clearly state the category of their services along with the certificates in the application for respective group or subgroup.
- (a) Manufacturer of aircraft and Manufacturer of components- CAT -1 (Manufacturer approval certificate)
 - (b) Manufacturer approved Maintenance Repair Organization or (OH Certificate)- CAT-2
 - (c) Manufacturer authorized Suppliers- CAT-3
 - (d) Suppliers of aircraft's spare parts - CAT- 4
5. Any company may be subjected to “**Capability and Quality Audit**” by a team of DGAA if deemed necessary even after it has been enlisted in the Annual Procurement List. The concerned company shall arrange the audit program and bear its total expenditure for this process.
6. If a local agent intends to enlist more than one company, application should be submitted separately with the above-mentioned requirements.
7. Failure to produce all the above motioned requirements will be disqualified.
8. DGAA reserves the rights to accept any application partly or wholly or reject it.
