Applications for Prequalification should be submitted in sealed envelopes, delivered to the address below by 12:00 noon of 31st day from the date of first publication of this notice, and be clearly marked "Application for the Construction of Water Supply distribution network, Electrification, Asphalt Concrete, Rigid Pavement and Park Beautification works in Dibeshwori Land Pooling Project "DLPP-73/74 /WS/E/R-01". Any applications after the above mentioned time and date will not be accepted.
- 6.The contractors and/or firms willing to submit their applications electronically shall either purchase the PQ document directly from the Employer office or may download the document from Web Site www.bolpatra.gov.npand submit the document in PDF files along with the scanned copy of Bank deposit voucher equivalent to payment of nonrefundable fee as specified in clause 4 by the time specified as in clause 5.The GON's e-procurement rules and procedures shall be followed by the bidders during the entire electronic procurement process.
- 7.If the last date for purchase or submission of Prequalificationdocument falls on public holiday the next consecutive working days shall be applicable for both purchase and submission.
- 8.The sealed envelope submitted shall be opened in the presence of contractor/firm's representatives who choose to attend at 2.00 PM on the last date of submission as specified in clause 5 with the authorized letter from the contractor /firm, at the address specified below however DLPP won't be held liable if contractors don't attend the bid opening meeting and will have all the right to open the sealed Pre-qualification envelopes as per the rules and regulations.
- 9.Information or data submitted by the company/firm which is incomplete or unclear or not substantiated by supporting documents shall not be considered for evaluation.
- 10. The Prospective Bidders are encouraged to visit the site in their own expenses and assess the conditions there of before applying for Prequalification. Employer has all the right to cancel the prequalification process if found necessary.
- 11. The employer reserves the right to accept or reject any Prequalification documents, and to annul the process and reject all Prequalification process at any time prior to the selection.
