Bidding is open to all eligible Nepalese Bidders.
2. *Division Forest Office, Rolla Libang* invites sealed bids from eligible bidders for the construction of *ThabangYudhaSmarakTathaSangrahalaya, Rolpa* under National Competitive Bidding procedures having key qualifications given in the table below should participate in this bidding:

A complete set of Bidding Documents may be purchased from the office *Division Forest Office Rolpa, Libang*, by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, Vat, Revenue, Tax clearance and upon payment of a non-refundable fee of **NRs 3000.00 (Three Thousand)** till **5 February 2019(2075/10/22 B.S.)**. However, the Employer will not be responsible for delay or non-delivery of the documents.

5. Pre-bid meeting shall be held at *Division Forest Office Rolla, Libang* at **14:00 on 31 Jan. 2019(2075/10/17 B.S.)**.
6. Sealed bids must be submitted to the office *Division Forest Office Rolpa, Libang* by bidder him/her self on or before **12hrs on 6 Feb. 2019 (2075/010/23 B.S.)**. Bids received after this deadline will be rejected.
7. Bids must be valid for a period of **90(Ninety) days** after bid opening and must be accompanied by a bid security amounts to a minimum of **NRs 4,80,000.00(Four Lakhs Eighty Thousand)**, which shall be valid for 30 days beyond the validity period of the bid (i.e. not less than 120 days after last date of bid submission).
8. The bids will be opened in the presence/or absence of Bidders' representatives who choose to attend at **13:00 hrs. on 6 Feb. 2019(2075/10/23 B.S.)** at Division Forest Office Rolpa, Libang.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
