The bid must include an original letter of authority to your local agent/representative/distributor in Nepal, who thereafter will be responsible for all dealings on your behalf, specially in smooth delivery of the goods. Commission to be given to the local agent must be declared; otherwise the submitted bid will be disqualified.
3. Bidder must submit their bid electronically as per e-GP System Operation Guidelines, 2074. Bidder can download the bidding documents for e-submission from PPMO's website www.bolpatra.gov.np/egp. Bidders submitting their bid electronically, should deposit the cost of bidding document in the account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

4. Pre-Bid Meeting shall be held at Police Head Quarters, Procurement Directorate, Naxal, Kathmandu on **30th May, 2019 (16th Jesth, 2076)** at 14:00 hours.
5. Electronic Bids must be submitted to the Procurement Directorate, Police Head Quarters, Naxal, Kathmandu through PPMO's website: www.bolpatra.gov.np/egp on or before **14th June, 2019 (31st Jesth, 2076)** at 12:00 noon. Documents received after this deadline shall not be accepted.
6. The Bids will be opened in the presence of Bidders' representatives who choose to attend **14th June, 2019 (31st Jesth, 2076)** at 14:00 hours at Procurement Directorate, Police Head Quarters, Naxal, Kathmandu Nepal. Bids must be valid for a period of **90 days** counting from the day of bid opening and must be accompanied by bid security, which shall be **valid for minimum 30 days** beyond the bid validity period.
7. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such case the bid validity and bid security shall remain the same as specified for the original last date of bid submission.
8. Police Headquarters, Naxal, Kathmandu reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason whatsoever.
